## NOTES FOR INTENDED COUPLE

*The intended couple agreed to abide by the requirements of the Authorized Marriage Celebrant, Mr. C.H. Eddy Au.*

\*\*\* ALL BRIDEGROOMS AND BRIDES MUST BE 18 YEARS OR OLDER. \*\*\*

1. There will be a **minimum** cost of \$350.00 for arrangement for a **marriage ceremony** normally. Each intended couple should pay the cost (as required) at the time of giving the **Notice** to the Authorized Celebrant. Other specific arrangements with special requirements may be negotiable.

2. More than one month (but less than eighteen months) before the date of marriage, a completed and witnessed **Notice of Intended Marriage** should be lodged with Mr. Au together with cost, the following document evidence or statutory declaration(s) attached to the **Notice**:-

(1) Payment (**non-refundable**) of cost (as required);

(2) For both the **Bridegroom** and the **Bride**:

\* Original Birth Certificate; or

\* Overseas Passport's personal details' page(s) and Original; or

\* Statutory Declaration made by the party or a parent of the party stating that,

for reasons specified in the declaration, it is impracticable to obtain such a certificate or extract and stating, to the best of the declarant's knowledge and belief and as accurately as the declarant has been able to ascertain, when and where the party was born. (Not applied to a party who was born in Australia);

(3) If a party is a **divorced person**, the original divorce (dissolution) Decree **Absolute** or **Certificate of Divorce** and a copy of it;

(4) If a party is a **widow** or **widower**, the original **Death Certificate** of her/his spouse and a copy of it.

( **All the original of the documents** listed above, **except Statutory Declaration(s)**, are for inspection and verification by Mr. Au at an interview before the marriage to be solemnized, they will be handed back to the intended couple. )

3. If the intended couple need their **interpreter(s)** at the ceremony, a **Statutory Declaration** form for each interpreter should be completed.
